- Laptops may be checked out in-person to St. Francis Xavier University students with a valid StFX ID card.
- The default borrowing period for laptops is 3 weeks, renewable once via automatic renewal, for 3 more weeks.
- Laptops returned late are subject to overdue fines of \$10.00 per day, up to \$30, with a 1-day grace period before fines are applied.
- Replacement fees of \$1500 will be applied to your StFX account after 3-days overdue and all library privileges will be revoked until the laptop and accessories are returned or paid. Replacement charges will be refunded upon laptop return.
- Any files or data saved to the laptop will be permanently deleted upon return to the library. Please save your files to your preferred cloud service or external storage device.
- All laptops, chargers, cables, and travel cases must be returned to a staff member at the Access Services Desk.
  Please do not place them in the drop boxes or leave on the counter unattended.

## **Angus L. Macdonald Library Laptop Liability Statement**

- I accept responsibility for the laptop while it is checked out to me from the StFX Angus L. Macdonald Library and will not leave it unattended or lend it to another person.
